### **1. Track State Qualifier Recognition**

#### **Discussion/Action Item**

Background: At a previous meeting it was discussed that recognition for track athletes who qualified and/or placed in the State track competition was lacking. After discussion, it was decided that a banner will be ordered for all track athletes that have qualified for the State competition dating back to at least 2015. A separate banner will be ordered for State champion.
