## **New Business**

### **1. Change of Construction Plans**

#### **Discussion Item**

Background: Current construction plans include having pickleball courts installed next to the tennis courts. Superintendent Ewald proposed that the plan be changed to construct the pickleball courts in the vacant area between the water plant and softball fields due to concerns with parking and constructing over existing irrigation and water lines. The Board reviewed the plans and agreed that the best location for the pickleball courts is by the softball fields. The architect will be contacted to make the change.

### **2. Potential Handbook Review**

Background: The Board reviewed some sections of the school handbook and agreed that some changes are necessary for the 2024-2025 school year handbook. Updates will be made at a later date.

### **3. Sexual Education Curriculum**
