New Business

1. Student Council Color Petition Presentation

Action/Discussion Item

Background: The Student Council previously brought forth a petition to add black as an official primary Caseville School color. The Board requested more information which the Student Council presented in hopes of approval.

Motion: Member Zagorski moved and Member Hopkins seconded to approve the addition of black as an official primary Caseville School color. Motion carried: 6 ayes, 0 nays, 1 absent.

2. ISD Elections

Action Item

Background: The Board of Huron ISD is holding a biennial election. Candidates Janice Holz and Carol Roggenbuck are running unopposed. The Caseville School Board will still need to cast their votes and approve the "resolution to consider designation of electoral representatives".

Motion: Member Yeager moved and Member Lapka seconded to approve the vote of Janice Holz and Carol Roggenbuck to the Board of Huron ISD. Motion carried: 6 ayes, 0 nays, 1 absent.

3. ISD Budget Resolution

Action Item

Background: Candice Halifax of Huron ISD presented their budget for the 2025-2026 school year. The school board needed to approve the budget.

Motion: Member Lapka moved and Member Yeager seconded to approve the Huron ISD budget resolution. Motion carried: 6 ayes, 0 nays, 1 absent.

4. Nature Trail and Track Signage

Discussion Item

Background: Rules needed to be determined for use of the nature trail and track regarding vehicles and pets. Signage conferring those rules will need to be ordered. Discussion was held and options for deterring vehicle use on and around the track were discussed. Options included additional fencing, a large archway at the beginning of the trees labeling "walking path", cameras by the path for monitoring, and signs on the fence claiming "no motorized vehicles".

5. Hiring of New JV Basketball Coach

Action Item

Background: Aaron Britt was brought forth as top contender for the JV Basketball coaching position. The Board will need to approve his hiring.

Motion: Member Zagorski moved and Member Lapka seconded to hire Aaron Britt as JV Basketball coach for the 2025-2026 season. Motion carried: 6 ayes, 0 nays, 1 absent.
